## Geographical boundaries:

Clarify that our boundaries include both sides of the boundary streets. Consensus accepted
Pheral: Proposes to include businesses on Illinois Avenue. Discussion followed
Pro: It makes sense to create a more mixed-use neighborhood.
Con: 1) This is an association that deals primarily with issues facing residents. 2) Most (maybe all?) businesses on Illinois are owned and operated by people who do not live in

Carbondale nor in our neighborhood. Their interests differ from and may well collide with residents. 3) Mixed use within a residential neighborhood is different from combining a business district with a residential neighborhood.
Discussion deferred.
Membership of the Board: Agreement that 5 at-large members is difficult to maintain. Proposed: change to a minimum of three at-large members

Other roles suggested: Organizational historian, webmaster, social media/communications. May or may not be a board member, or may serve on Board as ex officio (non-voting).
